DEPOSIT _____ (initials)

A down payment of \$200 is required to guarantee a reservation on all RV rentals. Estimated charges for the trip are due in full 30 DAYS PRIOR to the pick-up date. If today is less than 30 days from the pick-up date full payment is due now. Fractional Toys accepts Cash, Check, Cashier's Checks, Money Orders, VISA, MasterCard, Discover and America Express. **Personal Checks are not accepted less than 14 days prior to departure.**

CANCELLATION POLICY _____ (Initials)

From the date of the reservation to 30 days prior to the pick-up date. Fractional Toys will refund the down payment less a \$35 processing fee. **NO REFUND** will be given if cancellation is less than 30 days prior to departure date.

SECURITY/DAMAGE DEPOSIT _____ (Initials)
